RELEASE AND INDEMNITY AGREEMENT

The term club shall mean the Newton Yacht Club, Inc.

The grant of launching service, mooring, slip or dock space tie-up privilege, towing, hauling, or moving afloat or ashore, or any service whatsoever granted by the Club hereby agrees, that neither the Club nor any of its directors, officers, shareholders, employees, or agents assume any responsibility whatsoever for the safety of any boat at the Club either ashore or moored in the boat basin or adjoining waters or during launching, hauling or lifting operations, and none of them shall be liable to the member, applicant for membership and/or official guest of the Club, his or their family, employees, guests or invitees, however caused and whether or not caused by the default or negligence of the Club or any of its directors, officers, shareholders employees or agents.

In addition the member, applicant for membership and/or official guest of the Club does hereby indemnify and hold harmless the Club and its directors, officers, shareholders, employees and agents of and from any and all liability, claims and demand for damage to the property of and injuries to, or for property damage and personal injuries caused by, the member, applicant for membership and/or official guest of the Club, his or their family, employees, guests or invites.

The member, applicant for membership and/or official guest of the Club agrees that any grant of launching service shall constitute a rental of space only and no bailment of any kind is intended or created either expressed or implied. The member, applicant for membership and/or official guest of the Club, further agrees that all risk of loss, damage or destruction of said vessel, its equipment, or other property of

the member, applicant for membership and/or official guest of the Club shall at all times be borne by the member, applicant for membership, and/or official guest of the Club.

If accepted, I agree not to seek legal action against the Newton Yacht Club, Inc., Board of Directors, Officers and / or members as a result of the execution of its by-laws and rules. To engage in such activity would be considered "Conduct Unbecoming a Member" and could result in suspension or expulsion from the club.
